**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEBSTER, TEXAS, CANVASSING THE RETURNS OF THE GENERAL ELECTION HELD IN THE CITY OF WEBSTER, TEXAS, ON THE 10<sup>th</sup> DAY OF MAY 2008, FOR THE PURPOSE OF ELECTING A MAYOR AND ONE COUNCILMEMEBER, AND CANVASSING THE RETURNS OF THE SPECIAL ELECTION ON THE SAME DATE FOR THE PURPOSE OF ELECTING TWO COUNCILMEMBERS FOR UNEXPIRED TERMS.**


