RESOLUTION NO. 00-05

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEBSTER, TEXAS, CANVASSING THE RETURNS OF THE GENERAL ELECTION HELD IN THE CITY OF WEBSTER, TEXAS, ON THE 6th DAY OF MAY, 2000, FOR THE PURPOSE OF ELECTING TWO (2) COUNCILMEMEBERS; AND CANVASSING THE RETURNS OF THE SPECIAL ELECTION ON THE SAME DATE FOR THE PURPOSE OF ELECTING ONE (1) COUNCILMEMBER TO FILL AN UNEXPIRED TERM.**

WHEREAS, the City Council of the City of Webster, Texas in session, duly called the general and special city election to be held on the 6th of May, 2000, and the election returns of the 378 ballots cast in said election were canvassed for the following officials: Official for the office of Councilmember, Position 1; Councilmember, Position 2; and Councilmember, Position 5 (unexpired term).

Section 2. That the results of said special City election be and the same are hereby declared to have been as herein set out, and the following named person was




