



RESOLUTION NO. 96-05

**ORDER DECLARING FLOYD H. MYERS ELECTED TO THE OFFICE OF MAYOR AS AN UNOPPOSED CANDIDATE; DECLARING C. ERICK EDWARDS ELECTED TO THE OFFICE OF COUNCILMEMBER POSITION NO. 6 AS AN UNOPPOSED CANDIDATE; AND CANCELLING THE ELECTION SCHEDULED FOR MAY 4, 1996.**

**WHEREAS**, the City Council of the City of Webster, Texas, has scheduled an election for May 4, 1996, to elect the following officials for the City of Webster:

Mayor, and  
Councilmember Position No. 6; and

**WHEREAS**, Tex.ELEC.CODE § 2.053, provides that upon certification by the City Secretary that a candidate for office is unopposed, the City Council may declare the candidate elected and the need of holding the election for the position is avoided;

**WHEREAS**, the City Secretary has certified to City Council that each candidate whose name is to appear on the ballot for the above positions is unopposed; and

**WHEREAS**, no proposition is to appear on the ballot for the May 4, 1996, election. NOW THEREFORE,

**BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF WEBSTER, TEXAS:**

**SECTION 1:** That Floyd H. Myers, the unopposed candidate for Mayor of the City of Webster, Texas, is hereby elected to the office of the Mayor of the City of Webster, Texas, for the term beginning May 4, 1996.

**SECTION 2:** That C. Erick Edwards, the unopposed candidate for City of Webster Councilmember Position No. 6 is hereby elected to the office of City of Webster Councilmember Position No. 6, for the term beginning May 4, 1996.

**SECTION 3:** That as the requirements of Tex.ELEC.CODE § 2.052 for certifying unopposed candidates have been met, and the unopposed candidates have been elected to office by operation of statute, the election scheduled for May 4, 1996 is hereby cancelled. The City Secretary is directed to post a copy of this order on election day at each polling place that would have been used in the election scheduled for May 4, 1996 by the City of Webster, Texas. Furthermore, a Certificate of Election shall be issued to each candidate named above in the same manner as if those individuals had been elected at a duly held election.

It is so ordered, passed, and approved this 2nd day of April, 1996.
