NOTICE is hereby given of a Regular Meeting of the City Council of the City of Webster, County of Harris, State of Texas, to be held on Tuesday, September 15, 2020, at 6:00 PM at: City Hall Council Chambers, 101 Pennsylvania, Webster, Texas, for the purpose of considering the following numbered items. The City Council of the City of Webster, Texas, reserves the right to meet in closed session on any of the below items should the need arise and if applicable pursuant to authorization by Title 5, Chapter 551, of the Texas Government Code.

NEW BUSINESS

6. **CONSIDERATION/ACTION** to approve a Pipeline Permit Application for Magellan Crude Oil Pipeline Company, LP that authorizes the construction, operation and maintenance of two (2) 26-inch underground crude oil pipelines that will connect into the Exxon Terminal (Tank Farm) facility located at the corner of NASA 1 Bypass and TX Highway 3 in the City of Webster, Texas.
7. **CONSIDERATION/ACTION** to authorize the Police Department to enter into an Interlocal Agreement with the Harris County Sheriff's Office for "freeway non-consent tows" as part of a regional "Tow and Go" program.
8. **CONSIDERATION/ACTION** to approve and authorize the Mayor to execute an interlocal agreement with the Organized Crime Drug Enforcement Agency (DEA) Task Force for the purpose of fighting the illegal drug trafficking trade.

9. **CONSIDERATION/ACTION to adopt an ordinance of which the caption reads:**
AN ORDINANCE OF THE CITY OF WEBSTER, TEXAS, ADOPTING AND ESTABLISHING CHARGES FOR THE PROVISION OF UTILITY SERVICES; REPEALING OTHER SUCH FEE SCHEDULES HERETOFORE ADOPTED BY ORDINANCE, RESOLUTION OR MOTION OF THE CITY COUNCIL; CONTAINING A SAVINGS CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

- B. **Section 551.071(2), A governmental body may conduct a private consultation with its attorney:**

(2) on a matter in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with this chapter (regarding allegations by a former Public Works Department employee concerning his perceptions of the work environment at the Wastewater Treatment Plant and the Public Works Department and a potential administrative investigation to be conducted on behalf of the City Council as authorized by Section 3.12 of the City Charter).
