

RESOLUTION NO. 18- 10

**A RESOLUTION OF THE CITY OF WEBSTER, TEXAS,
DECLARING UNOPPOSED CANDIDATES IN THE MAY 5, 2018
GENERAL CITY ELECTION, ELECTED TO OFFICE; CANCELING
THE ELECTION; PROVIDING A SEVERABILITY CLAUSE; AND
PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the general city election was called for May 5, 2018, for the purpose of electing members to the city council; and

WHEREAS, the city secretary has certified in writing that no person has made a declaration of write-in candidacy, and that each candidate on the ballot is unopposed for election to office; and

WHEREAS, under these circumstances, Subchapter C, Chapter 2, Election Code, authorizes the city council to declare the candidates elected to office and cancel the election;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WEBSTER, TEXAS;

Section 1. The following candidates, who are unopposed in the May 5, 2018 general city election, are declared elected to office, and shall be issued certificates of election following the time the election would have been canvassed:

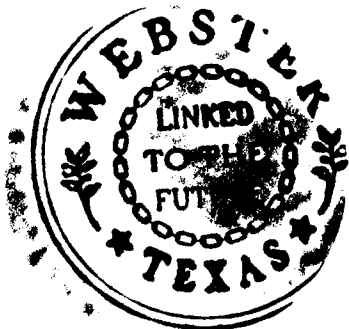

Andrea Giamfortone Wilson	Councilmember Position 2


Section 2. The May 5, 2018 general city election is canceled, and the city secretary is directed to cause a copy of this resolution to be posted on Election Day at each polling place used or that would have been used in the election.


Section 3. It is declared to be the intent of the city council that the phrases, clauses, sentences, paragraphs, and sections of this resolution are severable, and if any phrase, clause, sentence, paragraph, or section of this resolution is declared invalid by the judgment or decree of a court of competent jurisdiction, the invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this resolution since the city council would have enacted them without the invalid portion.

Section 4. This resolution shall take effect upon its final passage, and it is so ordered.
